History

The Government Finance Officers Association of South Carolina was established in 1984. We are a nonprofit organization under the laws of the State of South Carolina. Presently, our association has over 700 members representing state, county and municipal governments; special purpose and school districts; institutions of higher learning; and non-governmental, private businesses and corporations.

Objectives

One of the primary objectives of our organization is to promote and encourage professional competence of individuals who are responsible for and who hold in trust public funds. We are very proud of our accomplishments in addressing the professional development of finance directors, budget officers, and accounting managers.

Educational/Training Opportunities

We provide financial officers continuing education and training opportunities through our fall conference, spring conference, bimonthly luncheons, continuing professional education courses, and the Certification Program for Governmental Finance Officers. The Certification Program, spring conference, one day seminars, and the luncheons are held at locations in the Columbia area. The Fall Conference is usually held at a location away from Columbia.

Certification Program for Governmental Finance Officers

The Certification Program for Governmental Finance Officers is administered and offered for the Government Finance Officers Association of South Carolina by the Program for Leadership and Public Management of the University of South Carolina's Institute of Public Affairs. Successful completion of all requirements of the program will result in designation as a Certified Government Finance Officer.

Types of Membership

The GFOASC offers the following types of memberships:

Individual Membership

Individuals become active members upon payment of annual dues. Membership shall commence on the date membership fees are paid and end on the last day of December of the same year. Membership renewals shall end on the last day of December for the year renewed.

Agency/Political Subdivision Membership \$2,000

The \$2,000 Agency membership entitles a state agency or local government to an unlimited number of individuals to be placed on the membership register. If an agency membership is being requested, a list of names, with the membership data should be attached to this form.

Associate Sustaining Membership \$350

This membership is for an individual, non-governmental private business or corporation who wishes to contribute at a higher level of financial support. A list of names with the membership data should be attached.
